Summary

Controls and extinguishes fires, protects life and property, and maintains Fire Department equipment, building, and grounds by performing the following duties:

Essential Duties and Responsibilities

- Drives and operates all fire department vehicles
- Responds to medical emergency calls and performs as a team member until the emergency is over
- Responds to fire alarms and other emergency calls
- Participates in all phases of fire suppression activities, including but not limited to, interior fire attack, exterior fire attack, horizontal and vertical ventilation, salvage and overhaul operations
- Conducts routine inspections of fire department equipment and apparatus
- Performs routine maintenance and repairs on fire department equipment, quarters, buildings, and grounds
- Inspects fire hydrants for defects
- Attends training courses as assigned
- Participates in drills, parades, and fire safety educational programs
- Inspects buildings for fire hazards and compliance with local fire prevention codes
- Monitors weather conditions and dispatches warnings
- Prepares written reports and records
- Other duties as assigned

Education/Experience

- High school diploma or equivalent
- Successfully complete a Macon Fire Department Driver/Operator and Emergency Driving course within (6) six months of employment

- Proof of citizenship and/or eligibility to legally work in the United States of America
- Must submit to and pass a pre-employment drug test and background check
- Must comply with Employee Policy Manual residency requirements within sixty (60) days from date of hire
- Valid Missouri Driver License
- Certified Firefighter Level II within eighteen (18) months of employment
- Emergency Medical Responder or equivalent training
- Hazmat Operations within eighteen (18) months of employment

- Driving and operating motor vehicles and all Fire Department vehicles
- Maintaining fire department vehicles and equipment
- Computer operations and applications, including work processing and spreadsheets (Microsoft Office), audio-visual, and telephone equipment
- Using hand and power tools, power tools, and specialized fire suppression tools and equipment
- Communicate (orally and in written form) routine information, technical information, ideas to coworkers, supervisors, citizens, and other personnel
- Read and comprehend basic work instructions written in standard business English
- Read and interpret blueprints, building and fire codes, international fire training manuals, and other technical materials
- Add, subtract, multiply, divide whole numbers and fractions and calculate percentages, water flows, area, volume, proportions, etc.
- Use experience and training to select the most appropriate action to take or procedure to use when performing the job (problem solving ability)
- Organize daily work activities
- Remain calm and focused during emergencies
- Be thorough and accurate in performing inspections (attention to detail)
- Judge depth and distance (depth perception)
- See things clearly that are within arm's reach (near visual acuity)
- See thing clearly that are beyond arm's reach (far visual acuity)
- See colors (color vision)
- Hear (possess good hearing)
- Gather information through the sense of touch
- Gather information through the sense of smell
- Coordinate hand and foot movements with what is seen (eye-hand / eye-foot coordination)
- Manipulate objects using the fingers and hands (finger dexterity and manual dexterity)
- Lift and carry objects weighing up to 100 pounds
- Push, pull, or move objects weighing up to 100 pounds
- Drag, pull, or carry a person to safety
- Stoop, bend, twist, or kneel to perform work activities
- Walk, climb, and maintain balance
- Interpreting readings from measurement devices
- Investigating and determining the case of fire
- Providing training and instruction to individuals of all age groups

- Interacting with people and dealing with strained or violent personal contacts
- Work shift schedules
- Perform work from ladders and roofs, sometimes in excess of 75 feet above ground level
- Recognize defects in the mechanical operation or condition of assigned equipment
- Perform limited mechanical work in maintaining fire apparatus, equipment, and tools

Work Environment

- Works in an office/fire station and out-of-doors subject to all weather conditions
